JASPER MINING CORPORATION TO RAISE \$105,600 BY WAY OF PRIVATE PLACEMENT

Jasper Mining Corporation (the "Company")(JSP:TSX-V) is pleased to announce a non-brokered private placement of \$105,600 through the sale of 377,144 hard dollar units at \$0.28 per unit.
